Briefly the facts in this appeal are that Sh. Raj Kumar S/o Sh. Anant Ram R/o 127/9, Keran Gurha P/o Bantalab, Jammu moved an application dated 15-05-2013 under J&K RTI Act, 2009 before the Registrar, SKUAST seeking certain information.

The PIO furnished the information to the information seeker vide office letter no. AUJ/VC/GRTIC/13-14/RTI-19/13/75 dated 29-05-2013. The information seeker was informed that so far point no. 1, 2 & 3 are concerned, the University has not engaged any Class IV employee at their own on adhoc basis, daily basis, leave vacancy etc. and at present no engagement on adhoc basis etc. has been made in the University. However, the university is hiring services of labour, security guards etc. on through outsourcing. The information seeker was not satisfied with the information provided to him and preferred appeal dated 05-06-2013 before the FAA /

Registrar, SKUAST, Jammu. The FAA informed the information seeker vide office letter no. AUJ/Est/13-14/1930 dated 13-06-2013 that the information provided by the PIO is correct and it is as per the record of the University. The FAA also intimated the information seeker that as on date the University is not engaging any Class IV employee on adhoc basis / daily basis / leave vacancy etc. However, the University is hiring services of Labour, Security Guards etc. through outsourcing. The information seeker was not satisfied with the order of the FAA and he filed 2<sup>nd</sup> appeal dated 01-07-2013 before the Commission.

During the course of proceedings, the PIO informed the Commission that the information provided to the information seeker is correct and based on office record. Thus, the stand taken by the PIO as well as the FAA is upheld the 2<sup>nd</sup> appeal being without merit is dismissed.

Notice of this decision be given free of cost to the parties.
