Briefly the facts in this appeal are that Sh. Mohd. Sadiq R/o C-3, Village Enclave East Extension 1/C, Trikuta Nagar Jammu moved an application dated 15-05-2013 under J&K RTI Act, 2009 before the PIO / Addl. Dy. Commissioner, Kathua seeking the following information :-

1. Copy of SDM Basohli order No: SDMB/99 dated 11-07-2011.
2. BCG No. 308 dated 04-02-2011.
3. BCG 96 dated 22-07-2011
4. No. 103 (complaint)ADDC/K/CMP/10-11/57-60 dated 20-04-2011. Also provide me detail of status of this case and action taken by concerned department.

The perusal of the record shows that the information was furnished to the information seeker by Tehsildar, Basholi vide office letter no. OQ/RTI/2013-14/24-26 dated 17-06-2013. In his 2nd appeal before the Commission, the appellant has alleged that he has not been provided the following documents:-

1. Copy of No. 103(complaint)ADDC/K/CMP/10-11/57-60 dated 20-04-2011.
2. Status of this case and action taken in this regard.

The PIO/Tehsildar, Basholi in his counter statement filed before the Commission vide office letter no. OQ/41-43 dated 14-09-2013 which states interalia that the reply has already been submitted to the Deputy Commissioner, Kathua vide letter no. BCG/96 dated 22-07-2011 where under sanction for cancellation of RBA certificate issued in favour of Smt. Shama Parveen W/o Shokat ali R/o Nagali, Tehsil Basholi was sought but till date no direction/instruction has been received. During the course of proceedings the PIO/Tehsildar, Basholi assured the Commission that information sought by the information seeker relating to query no. 4 of his RTI application shall be furnished to him within three days positively.

In view of the aforesaid facts, the PIO/Tehsildar, Basholi is hereby directed to send information relating to query no. 4 to the information seeker under registered cover within three days from the date of pronouncement of this order and also file compliance report to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
