Briefly the facts in this appeal are that Sh. Koshistan Abdul Rashid Naik S/o Sh. Abdul Aziz Naik R/o W.No. 04, Ramban Teh. & District Ramban moved an application dated 29-04-2013 under J&K RTI Act, 2009 before the PIO O/o Chief Agriculture Officer, Ramban seeking the following information:-

"Date of Appointment of Sh. Ansar Rasool S/o Gh. Rasool Wani R/o Rallu Devgol, Banihal, order of appointment and copies of Pay Acquaintance Roll till date, Copy of appointment order of said Ansar Rasool as Rehbar-E-Zirat and details of pay/honorarium from the date of appointment till date."

The PIO/Chief Agriculture Officer, Ramban appeared in person before the Commission and apprised that the information was furnished to the information seeker within the statutory period and a copy of information was also endorsed to FAA i.e Director, Agriculture Jammu. The appellant feeling aggrieved of the information provided

to him, preferred Ist appeal dated 5-06-2013 before the Director, Agriculture Department, Jammu. The FAA directed the appellant to attend the hearing on 03-07-2013 but he chose to remain absent. The matter was disposed of and the requisite information was sent to him under a registered cover dated 04-07-2013. The allegations raised by the appellant in the second appeal before the Commission are baseless and not based on facts. The PIO/Chief Agriculture Officer, Ramban produced the acknowledgment dated 12-09-2013 duly signed by the appellant in which he has stated that he has received the entire information as requested by him in RTI application and does not want to pursue second appeal pending before the Commission. After hearing the PIO/ Chief Agriculture Officer, Ramban it is certain that the information was furnished to the information seeker within the statutory period and was also sent to him by the FAA as well.

In view of the facts narrated above, the information sought by the information seeker stands furnished to him and thus no further direction in the matter is required.

The appeal is accordingly disposed of.
