Briefly the facts in this appeal are that Sh. Mohd Sadiq R/o C-3 Village Enclave East Extension 1/C, Trikuta Nager, Jammu moved an application dated 20-05-2013 under J&K RTI Act, 2009 before the PIO/ Joint Director, School Education Jammu seeking the following information :-

1. Copy of order No. DSEJ/Mig/2195-96 dated 18-03-2004.
2. Copy of order No. DSEJ/Mig/3404 dated 14-08-2004
3. Copy of order No. DSEJ/Mig/Situ 320 dated 17-07-2004
4. Copy of Endorsement No. DSEJ/Mig/66 dated 01-08-2006
5. Copy of SRO No. 170 dated 16-06-2005.
6. Copy of SRO No. 225 dated 18-08-2005.
7. Copy of SRO No. 93 of 2009 dated 15-04-2009.

Perusal of the record reveals that the information seeker also filed Ist appeal dated 9-07-2013 before the FAA i.e Director, School Education Jammu in which he has alleged that the information provided by the PIO was incomplete and not as per his RTI application. The Ist appeal has not been adjudicated and disposed of till date. Thus, feeling aggrieved of inaction on the part of the PIO as well as FAA, the appellant preferred second appeal dated 22-08-2013 before the Commission in which he has requested that the PIO/FAA be directed to provide

the information relating to the following queries raised by him in his RTI application:-

1. Copy of order No. DSEJ/Mig/3404 dated 14-08-2004
2. Copy of order No. DSEJ/Mig/Situ 320 dated 17-07-2004
3. Copy of Endorsement No. DSEJ/Mig/66 dated 01-08-2006
4. Copy of order No. DSEJ/Mig/341 dated 14-08-2004

The Commission vide notice No:SIC/J/A/204/2013/3626-27 dated 09-09-2013 directed the PIO to appear before the Commission with counter statement and relevant documents on 19-09-2013 (10.15 A.M) at Jammu office of the Commission for hearing of the second appeal. The PIO failed to comply with the aforesaid direction and did not attend the Commission's office. The PIO is hereby directed to show cause why fine under section 15 of the RTI Act, 2009 read with Code of Civil Procedure Samvat 1977 shall not be imposed upon him for his failure to attend the hearing before the Commission within two weeks from the date of receipt of this order.

The PIO is further directed to provide the information to the appellant relating to all the four points raised by him in the second appeal before the Commission within 10 working days from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
