Briefly the facts in this appeal are that Sh. Jugal Kishore Verma R/o 732-D, Arorian Wali Chappadi, Prem Nagar, New Plot, Jammu moved an application dated 20-04-2013 under J&K RTI Act, 2009 before the PIO / Jammu Municipal Corporation, Town Hall, Jammu seeking the following information:-

Copy of the records pertaining to the lane between house of Sh. Jugal Kishore Verma, Elector No. LSW0985341, R/o House No. 732-D, Arorian Wali Chappadi, Prem Nagar, New Plot, Jammu and Sh. R.C Gupta, House No. 734-A, Arorian Wali Chappadi, Prem Nagar, New Plot, Jammu.

Perusal of record shows that the PIO/ Secretary, Municipal Corporation, Jammu vide office letter No:JMC/S/RTI/Comp/1563 dated 01-06-2013 on the basis of report of Executive Engineer ©, Jammu Municipal Corporation, Jammu provided the available information to the information seeker. In his second appeal before the Commission, the appellant has pleaded that he be provided exact dimensions of Kacha lane (not maintained by the Municipality) so that he can construct boundary wall of his house accordingly. The PIO/ Secretary, Municipal

Corporation, Jammu apprised the Commission that exact dimensions of the aforesaid lane are not available in the office record of Jammu Municipal Corporation and that can only be provided after making on spot inspection of the said lane. The PIO/ Secretary, Municipal Corporation, Jammu assured the Commission that the revised information will be provided to the information seeker within 10 days from the date of receipt of this order under an intimation to the Commission. Thus, no further direction in the matter is required.

The appeal is accordingly disposed of.
