Briefly the facts in this appeal are that Sh. Mohd Ayub Choudhary S/o Sh. Roshan Din R/o Village Dhanore Goursian, Tehsil and District Rajouri moved an application dated 23-05-2013 under J&K RTI Act, 2009 before the PIO/Registrar, Baba Ghulam Shah Badshah University, Dhanore Rajouri seeking the following information:-

- i. *About present existing strength of students, staff, teaching staff, families living within the University campus.*
- ii. *About facilities made available with regard to day to day fresh vegetables, milk, curd and fresh fruits like 'Kashmiri Roti'.*
- iii. *About if any NGO, Party or person willing to provide fresh vegetables, fresh milk/curd, fresh fruit, Kashmiri Roti to the students, staff, teaching staff and their families. Can such interested NGOs, Parties etc be provided space within the University complex, who will provide all such items on competitive rates within the University complex.*
- iv. *About if provision exists within the University complex for allowing interested party to sell fresh vegetables, fresh fruits, fresh milk/curd etc. What conditions shall be admissible to such interested parties under the norms and rules of the University, Can permission of staff be granted, provide conditions thereof.*

The PIO after seeking the approval of the authorities provided point wise information to the applicant within a statutory period vide office letter no. BGSBU/Estab/RTI/2013/6226-28 dated 28-06-2013 through registered post on the address provided by the applicant in his RTI application. Subsequently, the applicant addressed an appeal dated 01-07-2013 to the Registrar, BGSBU/1st Appellate Authority. On the direction of the FAA a copy of the sought for information was once again supplied to the information seeker vide letter no. BGSBU/Estab/RTI/2013/6738-41 dated 30-07-2013 through registered post.

Feeling aggrieved, the appellant approached the Commission by filing 2nd appeal dated 24-08-2013 with the plea that the PIO has not responded to the request in form-1 and no response was also given by FAA, BGSBU, Rajouri. The perusal of the record shows that information sought by the information seeker was provided to him twice.

During the course of proceedings held today, information seeker denied the receipt of these letters and apprised the Commission that till date he has not received any information send by the PIO / FAA, BGSBU, Rajouri. However, the PIO agreed to furnish another set of information to the information seeker as requested by him in his RTI application. The information seeker also acknowledged the receipt of the same. Thus the information as requested by the information seeker stands furnished to him and as such no further direction in the matter is required.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
