Briefly the facts in this appeal are that Sh. Mohd. Sadiq R/o C-3 Village Enclave East Extension 1/C, Trikuta Nager, Jammu moved an application dated 16-07-2013 under J&K RTI Act, 2009 before the PIO/ Dy. Superintendent of Police (Hqr), Headquarter Parade Ground Jammu seeking the following information :-

1. Detail of FIR registered against Forest land/grabbers in P/S Trikuta Nager and Channi Himmat till date.
2. Detail of absconders if any.
3. Detail of action taken in above mentioned matter.

The PIO submitted a counter statement to the Commission vide office letter NO:RTI/114/2013/3054/Dy. SPHQJ dated 23-09-2013 and intimated that the report obtained from Superintendent of Police, City South, Jammu vide his letter No:Rd/RTI/SPCS/18273 dated 30-07-2013 i.e 02 leaves was provided to the complainant after proper receipt vide office letter No: RTI/2013/114/2458-59 dated 01-08-2013. During the course of proceedings held today, the appellant acknowledged the receipt of the information and pointed out that the information

is not complete as he has not been provided the copies of the below mentioned FIR's alongwith the names of the alleged offenders:-

1. No:194/2012 under Section 447A RPC 6/39 Forest Act at Police Station, Bahu Fort Jammu.
2. 67/2012 U/s 447A/34/RPC P/S Channi Himmat
3. 24/2013 U/s 447A/RPC, 6/39 F.Act P/S Bahu Fort
4. 58/2013 U/S 447A/RPC, 6/39 F.Act P/S Bahu Fort
5. 109/2013 U/s 447A/RPC, 6/39 F.Act P/S Bahu Fort

The PIO agreed to furnish the above said information to the information seeker and requested that he may be given some time to collect the same from the concerned Police Stations. In view of the factual matrix of the matter in hand, the PIO is hereby directed to provide the requisite information to the information seeker which may include the copies of the above said FIRs alongwith the names of the alleged offenders within two weeks from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
