



6. How much payment made to the Printers against printing, mention the quantities of each item wise? Give photocopy of bills.
7. How much payment has been made to the lodging, hostel in the shape of boarding against how many pax. Give photocopy of bills.
8. How much payment has been made to transports and travelling agencies against conveyance and sightseeing? Give photocopy of bills.
9. For the valedictory function which held on 23rd of Feb. 2013. How much delegates visited Katra and Patnitop separately and how much food item arranged to them. Give detail.

The PIO forwarded the application of the information seeker to the Director Yoga Centre, University of Jammu followed by two reminders. The Director Yoga Centre, University of Jammu informed the information seeker vide office letter no. JU/YC/13/433-34 dated 10-05-2013 that the requisite information is ready in detail as per the queries and you are requested to collect the information after paying charges/cost of information as prescribed under the J&K RTI Act, 2009. Meanwhile, the information seeker preferred 1st appeal dated 16-05-2013 before the Registrar, University of Jammu alleging therein the non receipt of information from the Director Yoga Centre/PIO, Jammu. The 1st appeal was disposed of by the FAA/Registrar, University of Jammu vide office letter no. 1st AA/13/64-66 dated 19-06-2013 wherein Dr. D.L. Choudhary was directed to provide the desired information to the PIO for his onward transmission to the appellant within a period of 20 days from the date of receipt of the order under an intimation to the Registrar's office. In compliance to the aforesaid order Director, Yoga Centre, University of Jammu informed the PIO vide office letter no. JU/YC/2013/437-38 dated 26-06-2013 that Sh. Vipin Sharma visited his office after few days and all the relevant information, as desired was provided to him including publication of the souvenir of the conference by Times of India, procurement of conference bags by M/s Kundan Lal and Sons, boarding lodging facilities to the delegates, valedictory function at Katra, transport and travelling facilities provided to the delegates, detail regarding registration of the delegates as well as printing material of the conference etc.. However, the information seeker was not satisfied with the information provided to him as it was incomplete and not as per his RTI application. Thus, feeling aggrieved, he approached the Commission by way of filing 2nd appeal dated 29-08-2013 wherein he has requested that the PIO/Director, Yoga Centre, University of Jammu be directed to provide the requisite information which must be in conformity with the RTI application. The information seeker also submitted a letter bearing no. JU/G2SA/13/242 dated 16-09-2013 written to him by the Director, Yoga Centre, University of Jammu wherein some information sought by the information seeker has been conveyed to him. After going through the contents of the aforesaid letter, the Commission is of the considered opinion that the information seeker has raised queries in his RTI application which have to be answered with complete precision and as per specificity available in office record.

In view of the aforesaid observations and factual matrix of the matter in hand, the PIO is hereby directed to furnish the revised information to the information seeker answering all the queries raised by

the information seeker in the RTI application within 10 working days from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
