Briefly the facts in this appeal are that Ms. Shravani Sareen D/o Sh. S.M. Sareen R/o H. No. 55, Sector No. 2, Aap Shambhu Mandir Road, Upper Roop Nagar, Jammu moved an application dated 01-04-2013 under J&K RTI Act, 2009 before the PIO, University of Jammu, Jammu seeking the following information:-

- 1. Has the result of re-evaluation of the subjects Micro-Biology in both of its Theory Papers (I) & (II) and Forensic Medicine in both of its Theory Papers (I) & (II) of the applicant bearing Examination Roll No. 235/ASCM/09 & Registration no. 78-ASCM-09 of MBBS 2nd Prof. Examination been declared on account of which, the applicant has submitted the fee vide Receipt No. 397285 on 7th Dec.2012.*
- 2. If the said result has been declared, provide the complete details of the Marks obtained in the above mentioned two papers of the respective subjects.*

3. If the said result has not been declared, provide us the information when it is scheduled to be declared.

The PIO vide office letter no. PIO/JU/13/7125 dated 24-05-2013 informed the information seeker that the answer scripts of the candidate under reference were got examined from the expert of the concerned subject. However, the expert found that the evaluation done by the original evaluators in accordance with the performance of the candidate. The PIO furnished this information to the information seeker after receiving from concerned section. However, the information seeker was not satisfied with the information provided to her, she preferred 1st appeal dated 10-06-2013 before the FAA/Registrar, University of Jammu, Jammu which till date has not been adjudicated and disposed of. Thus feeling aggrieved of inaction on the part of FAA, the information seeker knocked the doors of the Commission by filing 2nd appeal dated 31-07-2013 alleging therein that the information provided to her is incomplete and misleading. The perusal of the RTI application and after hearing the information seeker and the PIO, it is crystal clear that the applicant is in need of the information regarding re-evaluation of papers i.e. marks she has secured after re-evaluation and she has prayed that the University authorities be directed to issue the marks sheet after re-evaluation. The 2nd appeal was listed for hearing on 24-09-2013, the PIO was directed to furnish the status of the case along with counter statement within a week's time and matter was again listed for hearing on 08-10-2013 and in compliance to the direction of the Commission the PIO furnished the requisite information to the information seeker vide office letter no. PIO/JU/13/10016-17 dated 08-10-2013 in which he has submitted that result has not been declared but however the 2nd re-evaluation has been got done from another expert and the marks awarded by the 2nd evaluators has been intimated to the information seeker vide aforesaid communication.

During the course of proceedings held today, the PIO furnished a set of information to the information seeker and also apprised the Commission that the result cannot be formally declared as there is no provision of re-evaluation in MBBS course. In view of the aforesaid facts and the submissions of the PIO, it is apparent that the information sought by the information seeker stands furnished to her including the marks obtained by her after revaluation. Thus no further direction in the matter is required.

The appeal is accordingly disposed of.
