Briefly the facts in this complaint are that Sh. Raman Sharma R/o K-236, Mast Garh, Jammu moved an application dated 04-04-2013 under J&K RTI Act, 2009 before the PIO/Jammu University, Jammu seeking certain information relating to Regular Candidates and Distance Mode Candidates which is as under:-

1. Under Jammu University rules, in how many days/months/years a Graduation Degree/Post Graduation Degree is awarded or handed over to the successful candidates both regular candidates also the candidates of the Distance Mode.

2. Total number of successful candidates who had not been issued their Graduation degrees/Post Graduation Degrees despite lapse of more than 5 years/10 years/20 years & more.
3. What procedure is adopted by the Jammu University in issuing degrees to the successful candidates? Regular & Distance Mode.
4. Provide detail of formalities required by a student to get his/her degree from Jammu. Regular & Distance Mode.
5. Under JU rules, the degrees are handed over to students personally or handed over to their respective educational institute.
6. What amount of fees a student/candidate is required to pay to get his/her Graduation Degree/Post Graduation Degree from Jammu University.
7. Total number of students/candidates of the women College Parade, Jammu who been issued their Graduation Degrees who have successfully passed their Graduation in the year 2007-08 & 2008-09.
8. Total number of students/candidates of the Women College Parade, Jammu who have not been issued their Graduation Degrees who have successfully passed their Graduation in the year 2007-08 and 2008-09.
9. At present total amount of fees a Candidate has to deposit to get his degree regular /distance mode candidate, Graduation Degree & Post Graduation Degree.

The PIO received the application of the applicant in his office on 16-04-2013 and forwarded the same to the Asstt. Registrar (Certificates), University of Jammu on the very next day vide No:PIO/JU/13/6722-23 dated 17-04-2013 followed by a reminder dated 07-05-2013.

The reply from the concerned officer i.e Asstt. Registrar (Certificates) was received in the office of PIO on 17-05-2013. On receipt of reply, PIO observed that the reply did not cover all the questions properly and the information received was incomplete and therefore, concerned Officer Asstt. Registrar (Certificates) was requested to make necessary corrections. The PIO also informed the appellant vide office letter No:PIO/JU/13/7107 dated 23-05-2013 about the corrections required in the reply furnished by the dealing office and intimated him that a week's time will be taken to complete the reply. The PIO also informed the complainant about the same telephonically and personally requested him for additional time in furnishing the reply. Finally, the corrected reply was received by the PIO from the concerned officer Asstt. Registrar (Certificates) on 25-05-2013 which was duly examined and sent to the complainant on 29-05-2013 vide No:PIO/JU/13/7169.

During the course of proceedings held today, the information seeker was contacted on phone to ascertain whether he has received the information or not. The information seeker apprised the Commission that the information sought by him in his RTI application has been duly received by him and expressed his satisfaction over the information provided to him and also appreciated the role of the PIO/University in taking prompt steps for providing the complete information as requested by him in his RTI application. Thus, the information as requested by the information seeker stands furnished to him. No further direction in the matter is required.

The complaint is accordingly disposed of.
