Briefly the facts in this appeal are that Sh. Mohd. Sadiq R/o C-3, Village Enclave East Extension 1/C, Trikuta Nagar, Jammu moved an application dated 27-05-2013 under J&K RTI Act, 2009 before the PIO O/o PWD (R&B), Rail Head Complex, Jammu seeking the following information :-

- 1. Detail of total tenders and names of contractors in Gandhi Nagar Constituency.*
- 2. Names of contractors who got work with tender and without tenders.*
- 3. Detail of work done from 2008 to 2012 in Gandhi Nagar Constituency.*
- 4. Detail of work done in ward no. 52.*

The PIO/Executive Engineer, PWD(R&B) Construction Divn. No. 1, Jammu vide office letter no. 4447 dated 07-10-2013 filed counter statement before the Commission and submitted that the information was provided to the appellant within the statutory period and also annexed a letter dated 17-07-2013 addressed to the PIO/Executive Engineer, PWD(R&B) Construction Divn. No. 1, Jammu

wherein the information seeker has acknowledged the receipt of complete information and also expressed his satisfaction over the same.

During the course of proceedings held today, the PIO submitted a set of information for the perusal of the Commission and after going through its contents the Commission found that the information as sought by the information seeker in his RTI application has been furnished to him. However, the PIO was directed to furnish the same set of information to the information seeker again against proper receipt and in compliance to the direction of the Commission the requisite information was furnished to the information seeker during the course of proceedings.

In view of the aforesaid observations, PIO is hereby directed to allow the information seeker an opportunity to inspect the record in his office on any working day and in case the information seeker requires the photocopies of relevant documents that may be provided to him free of cost. The parties are also directed to settle the date and time for inspection of record which would be mutually convenient to both of them.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
