Briefly the facts in this complaint are that Sh. Sanjay Kumar S/o Sh. Tara Chand R/o Ghai Jagir P/o Dadoa, Block Pouni, Teh. & Distt. Reasi moved an application dated 01-04-2013 under RTI Act, 2009 before the PIO O/o Directorate of School Education, Jammu wherein he sought certain information.

The copy of the aforesaid application of the complainant was transferred by Director School Education, Jammu to Chief Education Officer, Reasi vide letter no. DSEJ/RTI/2012/5547-50 dated 01-04-2013 which was received in the said office on 03-05-2013 and was further transferred to ZEO, Pouni vide office letter no. CEO/Rsi/RTI/1289-01 dated 03-05-2013 followed by a reminder vide letter no. CEO/Rsi/RTI/2429-30

dated 01-06-2013. The perusal of the record shows that ZEO, Pouni provided the requisite information to the information seeker vide office letter no. ZP/SSA/RTI/Nil dated 08-05-2013 and again on 25-07-2013. The CEO, Reasi in his counter statement vide office no. CEO/Rsi/RTI/4774-75 dated 24-07-2013 apprised the Commission that the information sought by the information seeker has already been provided to him within the statutory period and there is neither any delay nor any suppression of material facts and whatever information was available in office record that stands furnished to the information seeker. A set of information containing 11 leaves which has been furnished to the information seeker have been brought on the file for reference and record. Thus, the information as requested by the information seeker stands furnished to him and as such no further direction in the matter is required.

The complaint is accordingly disposed of.
