That on 25-05-2008 vide notification No. Re-evaluation /08/4726-38 the re-evaluation result was declared but the result of some course for which Fiaz Ahmed had applied was not declared but instead result of some other courses was declared by the university authorities of their own for which Fiaz Ahmed Roll No. 0024-DOG-05, had never applied at all.

- ii. As per the statutes Governing the Degree of M.Phil, 3. The minimum requirement for admission to the M.Phil Course shall be a Master's Degree examination in the Subject concerned or an allied subject in the second Division from a statutory University. But Parduman Singh S/o Sh. Padam Dev Singh who secured 49% third division in M.A got admission in M.Phil under 49% round up to 5% Vide univ. Notification No. F Acd/11/09/1013-1117 dated 11/2/09. He completed his M.Phil and doing P.hd in Jammu University. Sh. Fiaz Ahmed who secured third division in M.A Dogri got admission in M.Phil and after completing the course the university Authorities is not declaring the result of Fiaz Ahmed M.Phil student , University of Jammu roll No. 12-M-M.Phil-07.
- iii. Why the university continue the M.Phil course of Sh. Fiaz Ahmed when he had not fulfilled the eligibility conditions before I sem of M.Phil . In the mean time of the M.Phil Fiaz Ahmed has written several applications to the University authorities, why they did not give any reply.

The PIO vide office letter No:PIO/JU/12/6671 dated 5-04-2013 provided the requisite information to the information seeker. However, the information seeker was not satisfied with the information provided to him preferred Ist appeal dated

4-5-2013 before the Registrar, University of Jammu which was disposed of on 19-06-2013. Feeling aggrieved of the decision of the FAA, the appellant preferred second appeal dated 19-06-2013 before the Commission. After receiving the appeal of the information seeker, the Commission vide notice No:SIC/J/A/230/2013/3971 dated 1-10-2013 directed the PIO to send counter reply to the Commission within 7 days from the receipt of the notice and the matter was listed for hearing vide office notice No: SIC/J/A/230/2013/4053-54 dated 8-10-2013 on 21-10-2013 at Jammu office of Commission. The PIO in compliance to the aforesaid notice submitted the reply vide office No:PIO/JU/13/10105-07 dated 19-10-2013 and submitted the following points for perusal of the Commission:-

1. That the RTI application from Fiaz Ahmed S/o Sartaj Alam Sheikh R/o Batal Ballian Tehsil and District Udhampur under the J&K RTI Act, 2009 for seeking information was received in his office on 07-03-2013. The same was forwarded to the concerned offices i.e Controller of Examination on 08-03-2013 vide No's PIO/JU/13/6234, A.R-II (Exam/Prof) vide No. PIO/JU/13/6609 dated 01-04-2013, D.R (Eval/Prof) vide No. PIO/JU/13/6610 dated 01-04-2013 and Head, department of Dogri vide No. PIO/JU/13/6594 dated 01-04-2013.
2. The reply as received from the concerned offices was compiled and sent to the appellant vide No. PIO/JU/13/6671 dated 05-04-2013 which was within the stipulated time as mandated under the J&K RTI Act, 2009.

During the course of proceedings held on 21-10-2013, the appellant submitted before the Commission that PIO be directed to provide the Re-evaluation result of the following courses undertaken by him:-

The PIO was accordingly directed to communicate the result status of the appellant after re-evaluation. The matter was again listed for hearing on 01-11-2013 and during the course of proceedings, the PIO requested that University

requires some time to prepare the result of the candidate and assured the Commission that information will be provided to the information seeker as available in office record maintained by the office of Controller of Examinations, University of Jammu within 10 days. In view of the aforesaid facts and observations, the PIO is hereby directed to furnish the requisite information relating to aforesaid courses within 10 days from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
