Briefly the facts in this appeal are that Sh. Upjit Singh S/o Sh. Hari Singh R/o Near Piara Photo House Gurudwara Haft Chinar, Opposite Iqbal Park, J&K Bank A.T.M, Srinagar, Kashmir moved an application dated 10-07-2013 under J&K RTI Act, 2009 before the PIO/Asstt. Commissioner (Revenue), Jammu seeking certain information.

The PIO/Additional Deputy Commissioner, Jammu vide office no. DCJ/PIO/RTI/2013-14/1100 dated 24-10-2013 furnished some information to the information seeker. However, the information seeker was not satisfied with the information provided to him, he preferred 1<sup>st</sup> appeal before the Deputy Commissioner, Jammu which has not been adjudicated and disposed of till date. Thus, feeling aggrieved of inaction on the part of the FAA, the information seeker preferred 2<sup>nd</sup> appeal dated 23-09-2013 before the Commission alleging therein that the information provided to him is incomplete and incorrect. During the course of proceedings held today, AC(R), Jammu apprised the Commission that

the information as sought by the information seeker in his RTI application was provided to him vide no. DCJ/PIO/RTI/2013-14/2694 dated 21-10-2013. However, the perusal of information shows that it is incomplete and not as per his RTI application. In view of the aforesaid observations the PIO/Addl. Deputy Commissioner, Jammu is hereby directed to furnish the revised information as per office record to the information seeker which must be in conformity with the RTI application within two weeks from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
