Briefly the facts in this appeal are that Sh. Kiker Singh S/o Sh. Shiv Ram President Sudhar Sabha Committee, Village & PO. Hartaryan Teh. & Distt. Udhampur moved an application dated 11-06-2013 under J&K RTI Act, 2009 before the PIO/Block Development Officer, Udhampur seeking certain information relating to Panchayat Hartaryan, Sonari & Kambal Danga etc.

The PIO/BDO, Udhampur vide office letter no. BDOU/13-14/1838-41 dated 10-07-2013 requested the applicant to deposit an amount of Rs. 2880/- (Two thousand eight hundred and eighty only) (tentatively) as photostat charges so that the information as sought by the applicant could be provided to him. The applicant accordingly deposited the above said

amount as cost of the information and PIO/BDO, Udhampur furnished the requisite information comprising of 1440 pages to the information seeker. However, the information seeker was not satisfied with the information provided to him, preferred 1st appeal dated 30-08-2013 before the Director Rural Development Department, Jammu which was disposed of vide order no. DRDJ/RTI-319/2013/10812-16 dated 14-09-2013 directing the PIO/BDO, Udhampur to provide the requisite information as desired by the appellent within 7 days free of cost. The PIO/BDO, Udhampur submitted before the Commission that the requisite information as directed by the FAA was furnished to the information seeker. However, the information seeker has alleged in his 2nd appeal filed before the Commission that the information provided to him is incomplete and incorrect and not as per his RTI application. During the course of proceedings held today, the information seeker requested the Commission that the information pertaining to query no. 7,8,12,16 & 17 is incomplete and the documents provided to him by the PIO/BDO, Udhampur do not pertain to the information sought in the RTI application. The Commission after going through the contents of the information relating to above said queries is of the considered opinion that information provided to the information seeker is not as per his RTI application and the PIO/BDO, Udhampur agreed to furnish the revised information relating to the above stated queries.

Keeping in view the aforesaid facts and observations, the PIO/BDO, Udhampur is hereby directed to furnish the revised information relating to the above said queries free of cost within 10 days from the date of receipt of this order. The PIO/BDO, Udhampur is further directed to send the information to the information seeker under a registered cover and file compliance report to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
