



- i. Kindly provide me the steps taken by the Jammu Development Authority for vacation of above said 4300 sq. ft. of land from the illegal possession of above said Mamta Gupta.
- ii. Provide me the certified copies of the file notings of the file maintained in respect of the eviction proceedings of above said Mamta Gupta from above said 4300 sq.ft. of JDA land.
- iii. Provide me certified copy/copies of notice/s issued to said Mamta Gupta for the vacation of above said piece of land.
- iv. Kindly state whether the Jammu Development Authority has considered the auction of the above said piece of JDA land. If yes, kindly provide me the certified copies of the orders/opinions expressed or other record pertaining to said auction proceedings.

The respondent PIO provided the requisite information to the information seeker that the demarcation of land in question is yet to be conducted and further stated that the information sought by the appellant could be provided to him only after conducting the demarcation of said land.

The learned counsel for the appellant has submitted before the Commission that PIO has provided incorrect and false information and there is deliberate attempt on his part to conceal the information in order to give undue benefit to one Ms Mamta Gupta. He further submitted before the Commission that feeling aggrieved of the order of the PIO, the appellant filed Ist appeal under section 16(1) of the J&K RTI Act,2009 before the Vice-Chairman, JDA on 02-07-2013 and FAA did not pass any order in writing rather orally dismissed the Ist appeal filed by the appellant. Thus, feeling aggrieved of oral dismissal of appeal by the FAA, the appellant preferred second appeal before the Commission.

During the course of proceedings held today, the Director Land Management, JDA who appeared on behalf of PIO/Secretary, JDA, Jammu apprised the Commission about the steps taken by JDA for eviction of 4300 sq. ft. of land in possession of Ms Mamta Gupta and assured the Commission that certified copies of file notings of the file maintained in respect of the eviction proceedings by the JDA shall be provided to the appellant as per his RTI request.

In view of the aforesaid facts and observations, PIO/Secretary, JDA Jammu is hereby directed to furnish the requisite information as available in office record to the information seeker free of cost within 10 days from the date of receipt of this order. The PIO/Secretary, JDA Jammu is further directed to send the information to the information seeker under a registered cover and file compliance report to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
