Briefly the facts in this appeal are that Smt. Mamta Devi C/o Amrit Lal Sharma, Advocate, M.A. LL.B, (High court of J&K State) Presently Hon'ble District & Sessions Court Rajouri moved an application dated 10-07-2013 before the PIO /Dy. Commissioner, Rajouri under J&K RTI Act, 2009 whereunder she sought inter-alia certain information regarding Habitation Certificates issued by Tehsildar, Rajouri in favour of Tahira Kouser and Saira Kouser D/o Mohd. Sayeed Qureshi R/o Panjgrian, Tehsil and District Rajouri.

During the course of proceedings held today, Tehsildar Rajouri/APIO apprised the Commission that whatsoever information was available in the office record has already been furnished to the information seeker vide office

letter No: OQ/693 dated 04-10-2013 except query No. 10 and 12 which pertain to the office of Dy. Commissioner, Rajouri. The Tehsildar Rajouri/APIO also assured the Commission that in case the information seeker desires further information, she is at liberty to approach him in his office during office hours on a working day so that her grievance if any can be redressed.

In view of the aforesaid submissions of the Tehsildar Rajouri/APIO, the information seeker is hereby directed to approach the office of Tehsildar Rajouri on a working day during office hours and clarify/explain her request made in the RTI application in case she desires additional information.

The appeal is accordingly disposed of.
