Briefly the facts in this appeal are that Sh. Dharam Paul Sharma Retd. ZEO from Manjakot (Rajouri) R/o Ward No. 11, Hiranagar, Tehsil Hiranagar, District Kathua moved an application before the PIO/Directorate of School Education, Jammu under J&K RTI Act, 2009 whereunder he sought certain information relating to seniority list of Principals 10+2 who were due for regularization in terms of Government Order No:545 Edu of 2013 dated 21-05-2013.

The Directorate of School Education, Jammu vide letter No:DSEJ/RTI/2013/6868-72 dated 10-10-2013 forwarded the application of the information seeker to PIO/Under Secretary to Government, School Education Department, Srinagar. The Under Secretary to Government, School Education Department vide office No:Edu/ Gaz-III/06/2013/RTI dated 11-10-2013 informed the information seeker that **“you have been placed as I/c Principal w.e.f 03-05-2005 on notional basis (i.e the date when Shri Bansi Lal Gupta and**

Parveen Kumar Sharma were placed as such) in your own pay and grade, without charge allowances vide Government Order No. 545- Edu of 2013 dated 21-05-2013.”

The Under Secretary to Government, School Education Department further informed the information seeker that the department is not maintaining the seniority of I/C Principals and equivalent as same is not required to be maintained as per rule. As and when the regularization proposal of I/C Principal and equivalent (ZEO Cadre) is taken up with the Public Service Commission, your case alongwith others will also be examined under rules at that relevant point of time. The aforesaid letter is brought on record for reference.

From the contents of the aforesaid letter, it is crystal clear that the information as sought by the information seeker stands conveyed to him and as such no further direction in the matter is required.

The appeal is accordingly disposed of.
