Briefly the facts in this appeal are that Sh. Ajaat Jamwal R/o Village Nathwal A/p 253-A, Rehari Mohalla, Jammu filed an application dated 30-03-2013 before the PIO, Asstt. Commissioner Revenue, Samba under J&K RTI Act, 2009 whereunder he sought certain information relating to khasra No. 615 at village Salmeri, Tehsil & District Samba which was allotted to one Pritam Singh S/o Gian Singh R/o Nathwal.

The PIO/ACR Samba vide office No:DCS/HQA/RTI/2012-13/14-16 dated 2-04-2013 directed the Tehsildar Settlement, Vijaypur to furnish the requisite information to the office of ACR Samba within 20 days positively. Having received no response from the PIO, the information seeker filed Ist appeal dated 2-05-2013 before the FAA i.e Dy. Commissioner, Samba which was disposed of vide order No:DCS/HQA/RTI/2013-14/208-210 dated 06-06-2013 with the direction to PIO to provide the requisite information to the appellant within a period of one week positively and in compliance to the direction of FAA, the PIO/ACR furnished the requisite information to the information seeker vide No: DCS/HQA/RTI/2012-13/237 dated 13-06-2013. However, the information seeker was not satisfied with the information provided to him and filed second appeal dated 3-09-2013 before the Commission.

After receiving the second appeal, matter was listed for hearing several times. However, it had to be adjourned on the request of the parties. Moreover, some of the information sought by the information seeker in this case pertained to 3rd party i.e Mahavir International School, Salmeri, Tehsil and District Samba. Notice was also sent to 3rd party to remain present on the date of hearing and also file counter statement. In this case, 3rd party appeared through its counsel Sh. Amit Gupta on 08-11-2013 who sought time for filing the counter statement, but despite grant of sufficient time, third party failed to appear before the Commission and also could not file counterstatement as per direction of the Commission.

During the course of proceedings held today, the PIO apprised the Commission that Tehsildar Settlement, Vijaypur has furnished the entire information as sought by the information seeker in his RTI application. The said information was sent to the information seeker under a registered cover. The aforesaid letter of Tehsildar Settlement, Vijaypur and postal receipt has been brought on record for reference.

From the aforesaid facts and observations, it is apparent that the information sought by the information seeker stands furnished to him and as such no direction in the matter is required.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
