Briefly the facts in this appeal are that Sh. Ghar Singh, Security Guard, Security Office, University of Jammu, Jammu moved an application dated 04-02-2013 under J&K RTI Act, 2009 before the PIO/Jammu University, Jammu whereunder he sought the following information:-

“Ex-Serviceman Sh. Ghar Singh applied on application form No. 3635 dated 25-05-2007 but was shown as over aged for the post of Security Guard which was advertised as per University Advertisement Notice No:2235-357 dated 27-05-2007. It is requested to provide information as under which rule of J&K State Government, I was shown over aged while applying under category of Ex-Serviceman.”

Feeling aggrieved of inaction on the part of the PIO, the information seeker preferred Ist appeal dated 12-03-2013 before the Registrar, University of Jammu which has not been adjudicated and disposed of till date. Thus, feeling aggrieved of inaction on the part of the PIO as well as FAA, the information seeker knocked the doors of the Commission by filing second appeal dated 20-11-2013 wherein he has alleged that he was shown over age for the post of Security Guard in University of Jammu while applying under category of Ex-Serviceman.

During the course of proceedings, the appellant submitted that he received a reply from the PIO University of Jammu vide No: PIO/JU/13/6714 dated 16-04-2013 which says that the applicant has a meeting with the AR (C&R) personally and is completely satisfied with the replies made to the queries raised by the applicant. However, the applicant submitted that he is not at all satisfied by the verbal reply given by the concerned section because no specific information has been provided to him in writing.

In view of the aforesaid facts and observations, the PIO is hereby directed to provide the requisite information in writing to the information seeker free of cost as requested by him in his RTI application and as per office record within two weeks from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
