Briefly the facts in this appeal are that Sh. Dheeraj Kumar Sen C/o Ranjeet Singh Wazir R/o H. No. 459, Lane No. 3, Phase-III Suraksha Vihar Paloura Top, Jammu moved an application dated 14-05-2013 before the PIO Revenue Department, Tehsil Billawer, District Kathua under J&K RTI Act, 2009 whereunder he sought certain information relating to SRO-126 and SRO-294.

The appellant has complained that he has received no response for the information sought for from the PIO concerned. Whereas the PIO has explained in his letter No:DCK/RTI/12-13/86 dated 15-07-2013 that the requisite information under RTI Act was provided to the appellant vide letter No:DCK/RTI/2013-14 dated 24-06-2013 as received from Tehsildar, Billawar vide his letter No:BCG/259-61 dated 22-06-2013. Feeling aggrieved of the information provided to him, the appellant also preferred Ist appeal before the FAA (Revenue) i.e Dy. Commissioner, Kathua which was disposed of vide decision

No:DCK/ARA/RTI/2013-14/87-88 dated 28-08-2013. However, the appellant was not satisfied with the information provided to him by the PIO as well as the order passed by the FAA and approached the Commission wherein he has alleged that the requisite information sought by him in his RTI application has not been furnished to him.

The matter was listed before the Commission on 24-12-2013 and during the course of proceedings, the PIO/Addl. Dy. Commissioner, Kathua apprised the Commission that he has no objection in furnishing the revised information to the information seeker relating to SRO-126 and SRO-294 and sought 10 days time to provide the requisite information to the information seeker.

In view of the aforesaid facts and observations and the request of the PIO, it is hereby ordered that the revised information which exists in material form and as per office record be furnished to the information seeker under a registered cover at his residential address, within 10 days from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
