Briefly the facts in this appeal are that Sh. Chanchal Yogi S/o Sh. Jaimal Singh R/o Vill. Smailpur, Tehsil and District Samba moved an application dated 07-05-2013 before the PIO O/o Dy. Commissioner, Samba under J&K RTI Act, 2009 whereunder he sought the following information:-

- i. Kindly supply me the certified photocopies of the Khasra Girdawari for the years 1992 and 2012 of all the pieces of land, other than that which has been acquired by the Army, situated at village Smailpur and Village Meen Charkan, Tehsil Samba and District Jammu.*

Feeling aggrieved of in action on the part of the PIO, the appellant preferred 1st Appeal dated 05-07-2013 before the FAA/Deputy Commissioner, Samba which has not been adjudicated and disposed of till date. Thus, feeling aggrieved of in action on the part of the PIO as well as the FAA, the appellant filed 2nd appeal dated 24-09-2013 before the Commission. After receiving the 2nd appeal, matter was listed for hearing on 28-11-2013. The PIO was directed to file counter

statement before the Commission on next date of hearing and again the matter was listed for hearing on 19-12-2013.

During the course of proceedings held today, the appellant submitted before the Commission that he requires only certified photocopies of Khasra Girdawris mentioned in the RTI application filed by him in respect of Village Meen Charkan and Village Smailpur for the year 1992 & 2012. The PIO/AC(R), Samba agreed to furnish the requisite information to the information seeker and also submitted before the Commission that information sought by the information seeker is voluminous in nature and as such he can provide an opportunity to the information seeker to inspect the relevant record and in case the appellant requires photocopies of the relevant documents that will be provided to him on payment of requisite fee. The appellant also expressed his desire to inspect the record.

In view the aforesaid facts and observations, the PIO is hereby directed to allow an opportunity to the appellant to inspect the record and also provide him photocopies of the relevant documents on payment of requisite fee if any, required by the appellant. Parties are at liberty to settle the date and time for inspection of record which may be convenient to them.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
