The complainant filed an application dated 14-11-2013 before the Commission, wherein he has stated that he filed an RTI application before the PIO/Asstt. Director, CA&PD, Udhampur on 21-06-2013. The perusal of record shows that information was provided by the PIO on 10-07-2013, whereas the applicant was not satisfied with the reply provided by the PIO and preferred 1st appeal before the FAA/Director, CA&PD, Jammu on 16-09-2013. The FAA directed the PIO to provide the requisite information to the information seeker within a week's time. Due to non-compliance of the direction of the FAA, the information seeker filed an appeal before the Commission. The matter was listed for hearing on 30-10-2013, appellant could not cause his presence before the Commission and the PIO was present on the date of hearing. During the course of hearing on that day, the PIO apprised the Commission that the requisite information stands provided to the applicant within the statutory period as prescribed under the J&K RTI Act, 2009 and the matter was accordingly disposed of.

However, the information seeker filed an application on 14-11-2013 stating therein that he has not been provided information by the PIO in response to his RTI application filed on 21-06-2013. The application of the information seeker was listed for hearing on 27-12-2013 and both the parties were present. The RTI application of the information seeker was discussed threadbare and it was found that information provided to the information seeker does not correspond with his RTI application and is also incomplete in nature.

In view of the aforesaid facts and observations, the PIO is hereby directed to furnish the revised information relating to all the queries raised by the information seeker in his RTI application as per office record and free of cost within two weeks from the date of receipt of this order under an intimation to the Commission. The PIO is further directed to send the information to the information seeker under a registered cover at the address given in the RTI application.

The complaint is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
