The Commission vide its Decision No. SIC/J/A/99/2012/222, SIC/J/A/100/2012/222 and SIC/J/A/101/2012/222 dated 06-08-2012 directed the Assistant Commissioner (Revenue) / PIO, Samba to provide the following information to the information seeker within two weeks from the date of pronouncement of this order under an intimation to the Commission:-

"Whether the site plan of land measuring 4 marlas in respect of Khasra No. 232, Khewat No. 14, Khata No. 21 situated at Ward No. 4 near District Hospital, Samba issued by the revenue authorities is legal or illegal as the said site plan has been issued by the revenue authorities for the land measuring 8.7 marlas instead of 4 marlas".

The complainant Sh. Surinder Kumar Mishra filed an application before the Commission dated 10-10-2012 in which he has alleged that the aforesaid decision of the Commission has not been fully complied with. Accordingly the complaint was listed for hearing on 24-12-2012. During the course of proceedings held on that day the PIO informed the Commission that information has already been provided to the information seeker and order of the Commission was duly complied with. The PIO also assured the Commission to file a compliance report within a week's time. Consequently the AC(R)/PIO, Samba vide letter no. DCS/ARA/RTI/2012-13/1768-70 dated 24-12-2012 filed a compliance report which interalia reads as under:-

"Now as per direction of Commissioner the reply as given by Tehsildar Samba is hereby personally delivered to Sh. Surinder Kumar Mishra S/o Sh. Dev Raj Mishra R/o Ward No. 08, Samba on 24-12-2012 afternoon".

The complainant also acknowledged the receipt of the aforesaid letter which is placed in the file for reference and record. In view of the aforesaid facts, it is apparent that the information sought by the information seeker stands furnished to him.

The complaint for non-compliance is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
