Commission vide its Decision No. SIC/J/A/176/2012/359 dated 29-10-2012 had directed the PIO to furnish the revised information to the information seeker within two week's from the date of pronouncement of this order under an intimation to the Commission.

However, the information seeker has filed an application dated 04-02-2013 alleging therein the noncompliance of the aforesaid order of the Commission. The Asstt. Commissioner (Revenue), Jammu / PIO informed the Commission that the information was sent to the information seeker vide office letter no. DCJ/PIO/RTI/2012-13/3445 dated 06-12-2012 and the same has been duly received by the information seeker. Moreover, the information provided to the information seeker was as per the office record. The perusal of the information provided to the information seeker amply demonstrates

that the information has been prepared by the Naib-Tehsildar and Patwari Halqa as per the office record and the same is placed in the file for reference and record. The Commission cannot direct the PIO to create the information for the information seeker which is not available in the office record. The issue raised by the information seeker in his application for noncompliance relates more to redressal of his grievances and he is thus advised to approach the revenue authorities under the Revenue Laws for the redressal of the same.

The Complaint for noncompliance is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
