Briefly the facts in this appeal are that Sh. Mohd. Shafi S/o Sh. Rusla R/o Vill Bathoi, Tehsil Mahore, District Reasi moved an RTI application dated 08-05-2012 under J&K RTI Act, 2009 before the PIO / Chief Education Officer, Reasi seeking certain information.

The Chief Education Officer, Reasi forwarded the RTI application of the information seeker to Zonal Education Officer, Mahore/PIO for further necessary action in the matter. The Zonal Education Officer, Mohore requested the information seeker to deposit an amount of Rs. 1468/- as cost of the information vide letter No.ZEO/M/144 dated 11-05-2012. However, the complainant submitted his copy of BPL certificate on 19-05-2012. After receiving

the copy of BPL certificate, ZEO Mahore/PIO sent the information to the information seeker free of cost on 31-05-2012 through an employee of the office. But the information seeker refused to accept the said information. Subsequently information was sent to the information seeker through registered post on 08-06-2012. The PIO further submitted that some of the information was collected from the schools and after receiving the same it was sent through registered post weighing 3500 gm. The PIO also submitted documentary proof in support of the information which was sent through registered post. The information which pertained to ZEO Chassana was also sent to the information on 09-06-2012. The documentary evidence in support of that is also submitted for perusal of the Commission. After going through the facts and record of the case, Commission is of the considered view that information as requested by the information seeker stands already furnished to him by the concerned ZEOs. Second appeal preferred before the Commission is devoid of merit and is dismissed.

Notice of this decision be given free of cost to the parties.
