The Commission vide its decision No: SIC/J/A/174/2012/363 dated 31-10-2012 remanded the matter to the First Appellate Authority i.e Principal, Government Medical College, Jammu with a direction to dispose of the Ist appeal on merit after providing an adequate opportunity of being heard to the appellant and also ensure that the information sought by the information seeker shall be made available to him as per the office record, free of cost, within three weeks from the date of receipt of this order under an intimation to the Commission. It was also recorded that in case the information seeker is not satisfied with the information to be provided to him, he shall be at liberty to approach the Commission again.

Sh. Kailash C. Raina, the information seeker filed an application dated 30-11-2012 before the Commission in which he has alleged that

the information which has been furnished to him is incomplete and incorrect. The Commission after receiving the complaint for non-compliance issued notice to the PIO who vide office letter No :AHJ/RTI/2013/3010 dated 21-01-2013 informed the Commission that the requisite information as sought by the information seeker in his RTI application has already been provided to him without any delay.

The photocopies of the documents available in the file especially the office letter No:MS/RTI/424/9713 dated 30-11-2012 issued by the Medical Superintendent, SMGS Hospital, Jammu and also letter bearing No:RT/2012/544 dated 19-11-2012 issued by Dr. Ashutosh Gupta, Professor & Head, Regional Cancer Centre, Govt. Medical College, Jammu were furnished to the information seeker during the course of proceedings. The information seeker expressed his satisfaction as these documents contained the relevant information requested in the RTI application. In view of the aforesaid facts, it is thus apperent that the information as requested by the information seeker stands provided to him and there was no intention on the part of the PIO to conceal the information.

The complaint for non-compliance is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
