



Note:-No Bakerwal of Village Hartaryan & Sonari is owner of any land as intimated by the Settlement Tehsildar Udhampur. Therefore, they are to be considered as outsiders.

4. In case fresh ration cards have been issued against old ration cards in respect of S. No.2 above, date of issue of old ration cards and name of dealer/TSO be intimated alongwith Ration card No. of each individual.
5. Present position of the following issues:-
  - a) Proposal sent to higher authorities as per your No. 1656-58/AD/CAPD/Udh of 9-12-2011 & a copy of your letter under which the latest position has been ascertained from higher authorities.
  - a) Separate centre/sale depot in respect of vill:Hartaryan was requested as per our No. SSC/H/547-49 of 13-3-2012. A copy of the reminder issued in this regard.
6. Scale of sugar/ration/K.oil being supplied in respect of BPL, APL, AAY with rate per kg in respect of each item.
7. Village/ward No. column in the attached proforma has been left blank in most of the names which is to be completed in all respect.
8. As per statement provided & information given 380 APL are stated against Sh. Manoj Kumar dealer whereas only 378 APL are marked in the statement which is to be elucidated.

The information seeker had earlier moved a similar application dated 07-07-2012 seeking certain information from Assistant Director, Consumer Affairs & Public Distribution Department, Udhampur. The PIO/ Assistant Director, Consumer Affairs & Public Distribution Department, Udhampur furnished the information to the information seeker vide letter No:1183/AD/CAPD/UDH dated 14-11-2012 containing 65 leaves as enclosures. However, the information seeker returned the information to the PIO with the plea that the information provided to him was incomplete and incorrect and submitted another application dated 19-11-2012 in which he again requested for certain information which is almost similar to his earlier application. The information seeker feeling aggrieved of the information provided by the PIO/AD, CA&PD approached the Ist Appellate Authority by way of Ist appeal. The Ist Appellate Authority disposed of appeal vide its decision No:169/G/RTI/Appeal-04/199-200/G dated 04-02-2013 in which information sought in application dated 07-07-2012 was

adjudicated. The decision of the Ist Appellate Authority is based on merits and needs no interference and in compliance to the decision of the Ist Appellate Authority, PIO submitted before the Commission that he has furnished the information to the information seeker.

Meanwhile, the information seeker moved another application dated 19-11-2012 almost having the same queries and contents as raised by him in his first application. The PIO informed the Commission that he did not dispose of his second application as the information sought by the information seeker was almost similar which he had earlier requested in his first application. In case of second application dated 19-11-2012, the information seeker did not prefer first appeal and approached the Commission directly. The Commission would have treated it as complaint rather than second appeal. During the course of proceedings, the information seeker requested the Commission that he may be provided revised information as requested by him in his RTI application dated 19-11-2012 as it will also cover the information requested by him in his application dated 07-07-2012.

In view of the aforesaid facts, the PIO is hereby directed to furnish the revised information as available in the office record and free of cost to the information seeker within 2 weeks from the date of pronouncement of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
