### **Jammu 28-03-2013**

The Commission vide its Decision No. SIC/CO/A/219/2012/352 dated 12-12-2012 remanded the matter to 1<sup>st</sup> Appellate Authority / Deputy Commissioner, Jammu with a direction to adjudicate the appeal within 15 days from the receipt of this order after providing a due opportunity of being heard to the appellant. The appellant vide his application dated 07-01-2013 alleged that the aforesaid order of the Commission has not been complied with by the Deputy Commissioner, Jammu / FAA. On receiving the complaint for noncompliance, the Commission issued notices to Asstt. Commissioner (Nazool) and Tehsildar (Territorial), Jammu as the RTI application of the information seeker pertained to their offices.

The A.C.(Nazool) appeared before the Commission on 07-01-2013 and furnished the list of beneficiaries under J&K State Land Act-2001 to the information seeker. She further assured the Commission that she will provide information

pertaining to the cases which are pending in the court of law and also list of cases under process. The Tehsildar (Territorial), Jammu was also summoned to appear before the Commission and during the course of proceedings he informed the Commission that he has already provided the information to the information seeker vide office letter no. Teh/J/RTI/11-12/500 dated 28-02-2013. The copy of the said letter was also furnished to the Commission. However, the information seeker expressed the desire that he would like to access the record and Tehsildar (Territorial), Jammu agreed to provide an access to the number of registered and pending cases under the Roshni Act and available in the office record. In view of the aforesaid facts, the information seeker is directed to approach Tehsildar (Territorial), Jammu on 01-04-2013 onwards to access the record. Tehsildar (T), Jammu is also directed to provide the facility to the information seeker to access the information as available in office record during office hours from 01-04-2013 onwards.

The complaint for noncompliance is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
