The Commission vide its decision No: SIC/J/A/172/2012/360 dated 30-10-2012 directed the Sr. Town Planner, JMC to furnish the revised information to the information seeker in respect of Points 4 to 7 of his RTI application, free of cost, within two weeks from the date of pronouncement of this order under an intimation to the Commission.

However, the information seeker filed an application dated 19-11-2012 for non-compliance of the aforesaid decision of the Commission. Accordingly, the matter was listed for hearing on 06-02-2013 in which a direction was passed to provide the revised information to the information seeker relating to point No. 7 of his RTI application. Sh. Bharat Bushan Sharma, Building Officer JMC who appeared on behalf of the PIO assured the Commission that the request of the complainant relating to point No. 7 is being considered by the authorities and sought weeks's time to resolve the same provided the complainant submits an application to the Commissioner, Municipal Corporation Jammu i.e FAA for redressal of his grievances.

The complainant accordingly submitted his application dated 08-02-2013 before the Commissioner, JMC and to comply with the direction of the Commission,

the Sr. Town Planner (Secretary, BOCA) JMC vide office letter No:699-704/BS/2012 dated 30-03-2013 furnished the requisite information to the information seeker. In the aforesaid letter, it is stated that the building permission already issued vide order No:330/BS/2010 dated 12-06-2010 is hereby modified as per decision of BOCA dated 19-02-2013 in favour of Smt. Jyotsana Mohan W/o Sh. Arun Kumar Sharma at H.No-202, Mohalla Paharian, Jammu with the condition that the applicant should close the ventilator at the existing ground floor towards drain. The letter also contains the site plan of the building and is placed on the file for reference and record. Sh. Sanjeev Kumar who appeared on behalf of Sh. Bishan Dass was also provided a photocopy of the aforesaid letter and the site plan, during the course of proceedings. He expressed his satisfaction and submitted that the information as sought by him now stands furnished to him. In view of the aforesaid facts, there is thus no requirement for passing any further direction in the matter.

The complaint for non-compliance is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
