The Commission vide its Decision No. SIC/J/C/186/2012/408 dated 13-02-2013 directed the PIO to provide the information as requisitioned by the information seeker in his RTI application and in compliance to the direction of the Commission the PIO / Wildlife Prosecutor furnished the information to the information seeker vide office letter no. WLP/Estt/RTI/2013/2084 dated 13-02-2013. However, the information seeker filed an application dated 26-02-2013 before the Commission alleging therein that the information provided to him was false and not as per the office record. After receiving the complaint from the information seeker, the matter was listed for hearing on 10-04-2013.

During the course of proceedings, the PIO filed a counter statement dated 10-04-2013 submitting therein the compliance of the aforesaid order of the Commission passed on 13-02-2013. The PIO informed the Commission that the information was collected from Wildlife Warden, Kathua Sh. Saleem-ul-Haq who is designated as PIO

and after collecting the same it was furnished to the information seeker by hand on 14-02-2013 as per the order of the Commission. The perusal of the information provided to the information seeker shows that the information relating to point 'D' of RTI application is deficient in nature as the information seeker has asked

"was Mr. Vijay Kumar S/o Sain Dass of District Kathua was appointed on the basis of advertisement / interview or otherwise. If so, provide a copy as a proof of advertisement / call up letter for interview".

The PIO is directed to provide relevant information relating to advertisement / call up letter for interview as available in the office record. The PIO assured the Commission that he will provide information relating to the aforesaid point today itself to the information seeker and file compliance report to the Commission.

The complaint for noncompliance is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
