
In supersession of the Commission order No. 28-SIC/CO of 2011 dated 28.10.2011 and in exercise of powers conferred on him under Section 12(4) of the J&K RTI Act.2009 read with Rule 25(1) of J&K RTI Rules 2010, the CIC has made re-allocation of public authorities/departments and other organizations/bodies to CIC/Information Commissioners as under:-

S.No.	Name of Public authorities /departments/organizations/bodies	Allocated to :
1.	All public authorities /departments/organizations/bodies which are moving with Darbar Move besides PWD(R&B) of Kashmir Division and University of Jammu	Shri G.R.Sufi, CIC
2.	All Non-moving public authorities /departments/organizations/bodies of Jammu Division besides Office of Income Tax Deptt.at Jammu	Dr. S.K.Sharma, State Information Commissioner.
3.	All Non-Moving public authorities/departments/organizations/bodies of Kashmir Division including Ladakh besides Office of Income Tax Deptt.at Srinagar	Shri Nazir Ahmed, State Information Commissioner.

The CIC will have concurrent jurisdiction with both the State Information Commissioners to list/hear any case assigned to the ICs.

The penalty proceedings and similar other post-disposal actions, wherever required, shall be carried to a logical end by the respective State Information Commissioners in respect of cases falling under their allocation including such complaint/appeal cases as have been heard and disposed of by the CIC prior to November 2011.
